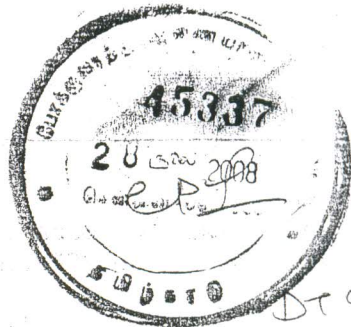

**ORDER:**

In the Government Order fourth read above draft amendments have been issued omitting the provisions in sub-rules 5, 7 (1) (i) and 8 of rule 169-A of the Tamil Nadu Motor Vehicles Rules, 1989 providing for fixation of age limit in respect of tourist maxi cab and motor cabs. The same has been published in Home Department Notification No. SRO A- 17 (a)/ 2008 at pages 1 and 2 of Part III- Section 1(a) of the Tamil Nadu Government Gazette Extraordinary, dated 03.06.2008.

2. No representations have been received from the public objecting the said draft amendments. The Government have decided to amend rule 169-A of the Tamil Nadu Motor Vehicles Rules, 1989 omitting the provisions fixing age limit of maxi cab and motor cab by confirming the said draft amendments issued in G.O.(Ms).638, Home dated 03.06.2008 and published in the said Tamil Nadu Government Gazette Extraordinary, dated 03.06.2008, Accordingly, the following

In exercise of the powers conferred under section 95 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Motor Vehicles Rules, 1989, the same having been previously published, as required by sub-section (1) of section 212 of the said Act.

**AMENDMENTS**

In the said Rules, in the rule 169-A,-

- (i) sub-rule (5) shall be omitted;
- (ii) in sub-rule (7), clause (i) shall be omitted;
- (iii) sub-rule (8) shall be omitted.
