NOTIFICATION

The following draft of amendment to the Tamil Nadu Motor Vehicles Rules, 1989, which if is proposed to be made in exercise of the powers conferred by section 95 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), is here by published for the information of all persons likely to be affected thereby, as required by sub-section (1)of section 212 of the said Act .

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of the period of thirty days from the date of publication this Notification in the Tamil Nadu Government Gazette and that any objection and suggestion, which may be received' from any person with respect there to before .the expiry of the aforesaid period will be considered by the Government of Tamil Nadu..

3. Objection and suggestion, if any, should be addressed in duplicate to the Principal Secretary to Government, Home Department, Secretariat, Chennai-600 009. .

DRAFT AMENDMENT

In the said Rules, in rule 235, in sub-rule 2, after clause (b), the following clause shall be added namely:-

"(c) An application for grant, of such agent's licence shall be accompanied by a security deposit at the rates specified in the Table below:-

THE TABLE

Place of Business	Security Deposit (Rs.)
Corporation limits	20,000/-
*Town limits	10000/-
Other places,	5,000/-

" Town limit means "any area within Municipal Limit"

EXPLANATORY NOTE.

As per sub-sections (1) and (2) of section 93 of the Motor Vehicles Act, 1988; booking agents licence has to be obtained for carrying the business of collecting, forwarding or distributing goods through goods carriages. Subsection (2) of section 93 of the said act provides for prescription of security deposit for obtaining such licence.. But no such security deposit has been prescribed in the Tamil Nadu Motor Vehicles Rules' 1989 which has resulted in loss of revenue to Government. Therefore it has 'been proposed to fix different rates of Security deposit for applying for the licence for goods booking agent, in Corporation limit, town limit and other places. The above draft amendment provides for this.
