O R D E R

At present the following fixed rates are being charged from the Officers fro using the staff care namely:-

In the city of Madras

Sl. No.	Distance between the place of residence and office	Monthly charges	Monthly fuel ceiling for each vehicle allowed both for private and official purposes.
i)	Upto 8 Kms	Rs.125/-	100 Litres
ii)	Over 8 Kms Upto 12 Kms	Rs.150/-	125 Litres
iii)	Over 12 Kms Upto 16 Kms	Rs.175/-	150 Litres

II. In the Mofussil Station

Sl. No.	Distance between the place of residence and office	Monthly charges	Monthly fuel ceiling for each vehicle allowed both for private and official purposes.
i)	Upto 4 Kms	Rs.60/-	50 Litres
ii)	Over 4 Kms Upto 8 Kms	Rs.125/-	100 Litres
iii)	Over 8 Kms Upto 12 Kms	Rs.150/-	125 Litres
iv)	Above 12 Kms and Upto 16 kms	Rs.175/-	150 Litres

Above concession is entitled to be availed by the following officers as per G.O.Ms.No.166, Public (Motor Vehicles II) Department, dt 1.2.85.

- i) Secretary to Government
- ii) Additional Secretary to Government
- iii) Heads of Department .

As per the orders issued in g.O.Ms.No.1886 Home, dt.11.11.91 the concession has been extended to some IInd level Officers as noted below, subject to the condition that if any second vehicle is already available in the department.

- 1) Joint Secretary to Government – in Secretariat.
- 2) Joint Commissioners In Heads of Department.
- 3) Additional Directors.

2. While such is the position, the examiner of Local Fund Account (as a Head of Department) has stated that his residence is situated as Pammal and the distance between office and residence (to and fro) is 40 Kms and requested the Government to extend the concession of using staff beyond 16 Kms. Due to actual concession in city for carrying accommodation etc., the Government have liberalized the House Building Advance Rules and encouraged the officers to build houses in the outskirts of Madras city and other major cities in the State even exceeding 16 kms without prescribing any limit. Consequent on this un mindful of these restrictions on use of official vehicles many officers are living in outskirts of city limits and on this account, rejecting a privilege entitled to a Heads of Department may not be based on strong grounds.

3. The Government have therefore examined the proposal in detail as a general question in consultation with the Director Motor Vehicles Maintenance Department and accordingly direct that the following rates of fixed charges be collected from the officers for using the Government vehicles who are entitled to avail such concession.

In the City of Madras

Distance between the place or residence and office	Monthly Charges (Rs)	Monthly fuel coiling for each vehicles (both for private and official purposes)

Over 16 Kms and Upto 20Kms	225.00	160 Litres
Over 20 Kms and Upto 25Kms	300.00	170 Litres

3. Other orders are already in force for the use of Government Vehicles and rule 4 of the Tamil Nadu Departmental Vehicles Control Rules, 1976 shall be followed.
