**ORDER:**

In G.O.Ms.No 958, Home dated 2.5.1978, the Government approved the proposal of the Transport commissioner for decentralization of administrative powers. The Transport commissioner has reported that in the above Government order appointing authorities for the categories or Motor Vehicle Inspector Grade I and II, Statistical Inspector, Head Clerk, Shroff, Record clerk, Driver, Last Grade Government servant and reader and examiner have not been detailed and that due to administrative difficulties the matter of maintaining division- wise seniority of Assistant in all the officer in the Transport department may be the Joint Transport Commissioner. He has proposed that the orders issued in the Government order referred to above may be modified to this extent.

2. According to the existing Special Rules for the Tamil Nadu General Subordinate Service, the appointing authority for the post of Motor Vehicles Inspector Grade I and Grade II in the Joint Transport Commissioner. Further according to the Special Rules for the Tamilnadu Basic Servant, the appointing authority for the posts under classes III, IV and V in the office of the Regional Transport Officer concerned. Therefore there is no need to indicate the appointing authority in respect or the above posts.

3. The appointing authority for the following posts in the Transport Department shall be as detailed below:
